

Giorgos Fourtounis (PhD in Philosophy of Science) is Assistant Professor of Philosophy in the Department of Political Science and History, Panteion University (Athens, Greece). One of his major research orientations is French post-war philosophy, especially the so-called "(post)structuralism" and "historical epistemology", and in particular the works of Althusser, Foucault and Canguilhem. He publishes regularly on these topics and he is co-author (with A. Baltas) of *Louis Althusser and the End of Classical Marxism: the Precarious Immortality of a "Null" Philosophy* (Athens 1994, in Greek).

G. Michael Goshgarian taught American literature and civilization for eleven years at the University of Burgundy in Dijon before becoming a fulltime freelance translator from French, German, and Armenian into English in 2000. He has translated three collections of Louis Althusser's posthumous writings into English for Verso Books and written lengthy introductions to two of them. He is currently working toward the publication in English translation of a number of unpublished books and other texts by Althusser. He lives in Paris and Berlin.

Slobodan Karamanić is Research Assistant at the Department of History and Sociology, University of Konstanz (Germany) and PhD candidate at Ljubljana Graduate School of the Humanities (thesis proposed: Louis Althusser: Theory and Politics outside the State). Vittorio Morfino is a researcher in the History of Philosophy at the Università di Milano-Bicocca. He is the author of "Substantia sive Organismus" (1997), "Sulla violenza. Una lettura di Hegel" (2000), "Il tempo e l'occasione. L'incontro Spinoza Machiavelli" (2002), "IncurSIONI spinoziste" (2002) e "Il tempo della moltitudine" (2005). He has edited "Spinoza contra Leibniz" (1994), "La Spinoza Renaissance nella Germania di fine Settecento" (2000), "L'abisso dell'unica sostanza" (2009), as well as the Italian edition of the late writings of Louis Althusser (2000) and "Logica e teoria della scienza di Jean Cavaillès" (2006); he is an editor of "Quaderni materialisti".

Ozren Pupovac is a fellow at the Institute for Cultural Inquiry in Berlin, where he runs, together with Bruno Besana, the *Versus Laboratory* philosophy seminars. His research interests are framed at the meeting points between Marxist thought, contemporary French philosophy and German Idealism. He has also contributed to the intellectual debates concerning Yugoslav socialism, and has written critically on post-Marxism and post-socialism. He translated Alain Badiou's *The Century*, and *Of an Obscure Disaster* (together with Ivana Momčilović) into Serbocroatian. He is currently editing and translating a collection of Althusser's writings into Croatoserbian under the title *Interventions of Philosophy*.

Jason Read is Assistant Professor of Philosophy at the University of Southern Maine. He is the author of *The Micro-Politics of Capital: Marx and the Prehistory of the Present* (Albany: SUNY, 2003) as well as numerous articles on Althusser, Negri, Spinoza, Foucault, Deleuze and Guattari. He is currently working on a manuscript which explores collectivity as the point of articulation of the social and the political.
